Introduction

BDO Advisory Services (Pty) Ltd (BDO) is the appointed Independent Electoral Body (IEB) for Bankmed's Annual General Meeting (AGM) and Trustee Elections. The AGM is once again, convening virtually in 2025.

The virtual AGM will be facilitated online using a dedicated website that incorporates the AGM-related information, voting on motions and the live-stream of the virtual AGM. To ensure a seamless process, Bankmed has ensured that access to the AGM website and proceedings are data free.

The website and live event are accessible from a computer or mobile phone and depend on a stable internet connection. You will not require an MS Teams profile to access the AGM, as the entire process is housed within the website.

The event is open to all Principal Members and pre-approved non-voting attendees. There is no preregistration requirement for the 2025 AGM.

Process

To access the AGM, please follow these steps:

- Access the AGM website <u>here</u> (or type the following address into your web browser: <u>https://bankmedagm.bdo.co.za/</u>). The website is currently closed, but will be active closer to the AGM date.
- ii) Information related to the AGM is contained under the link "AGM Information" and the Frequently Asked Questions (FAQs).
- iii) Authenticate your membership to confirm your identity by clicking the "Authenticate" button.
- iv) Once authenticated, you will note a new menu option to "Access the AGM" in the menu items on the right.
- v) Click on the "Access the AGM" link, and you will be directed to a new page in your browser with a built-in webcast window to the AGM event. This page contains four (4) clickable boxes on the left of the webcast window:
 - Return to Home Page this button will take you to the Home page.
 - Chat this button will open the chat functionality for questions and answers during the AGM.
 This will pop up as a window on the Access the AGM page. All moderated comments will be published in this field. Answers to questions will also be posted in the same field.
 - Vote on Motions (Member) this button will open the voting window as a pop-up on the Access the AGM page.
 - Vote on Motions (Proxy) this button will open the voting window for Proxy votes as a pop-up on the Access the AGM page. Please note that only those members with a pre-approved Proxy will see this option.

Communication during the AGM

The Question & Answer Function

Due to the nature of the virtual event platform and the number of expected attendees, all attendees will be muted and unable to speak during the event. Despite this limitation, you can still communicate your questions and comments via the built-in Chat function on the "Access the AGM" page. This will serve as the question and answer (Q&A) function for the AGM.

The following process will be followed regarding comments and questions submitted via the Q&A facility:

- i) The IEB will moderate all submissions to determine applicability, sensitivity and appropriateness.
- ii) Submissions will be published on the live event and appear in the Q&A section.
- iii) Questions and comments related to the AGM's business will be answered during the AGM by the Bankmed panel, time permitting.
- iv) Questions and comments unrelated to the business of the AGM or not answered at the AGM will be answered by Bankmed within seven (7) business days of the AGM. These answers will be published on the Bankmed website (www.bankmed.co.za).
